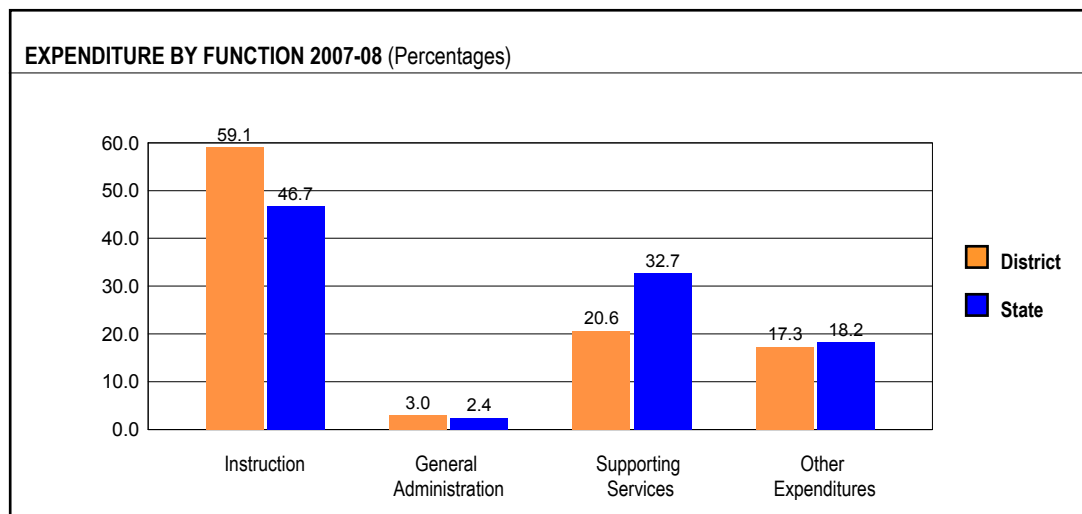

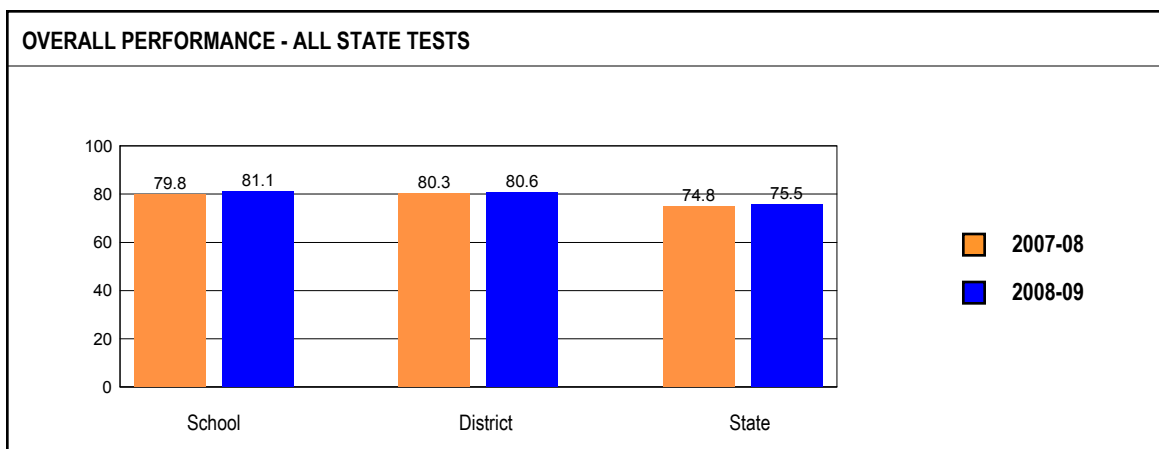

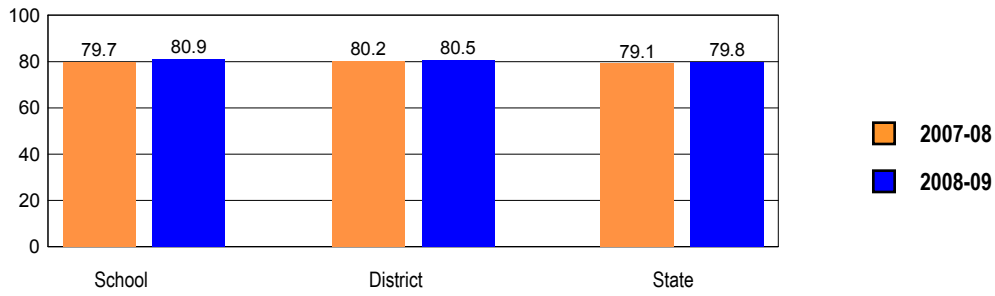
OVERALL STUDENT PERFORMANCE

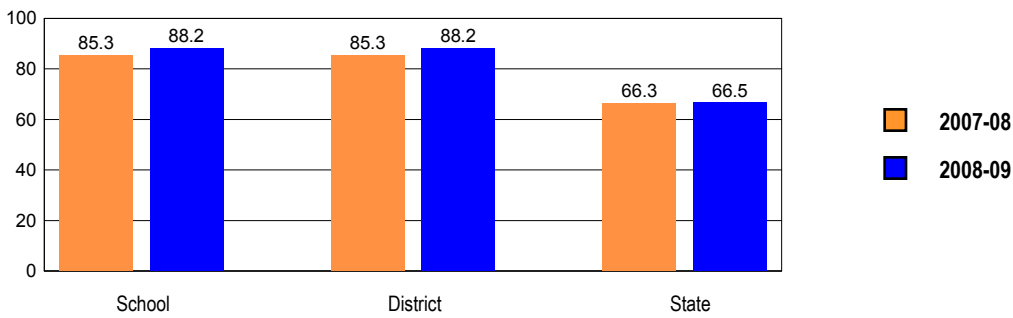

OVERALL ILLINOIS ALTERNATE ASSESSMENT (IAA) PERFORMANCE

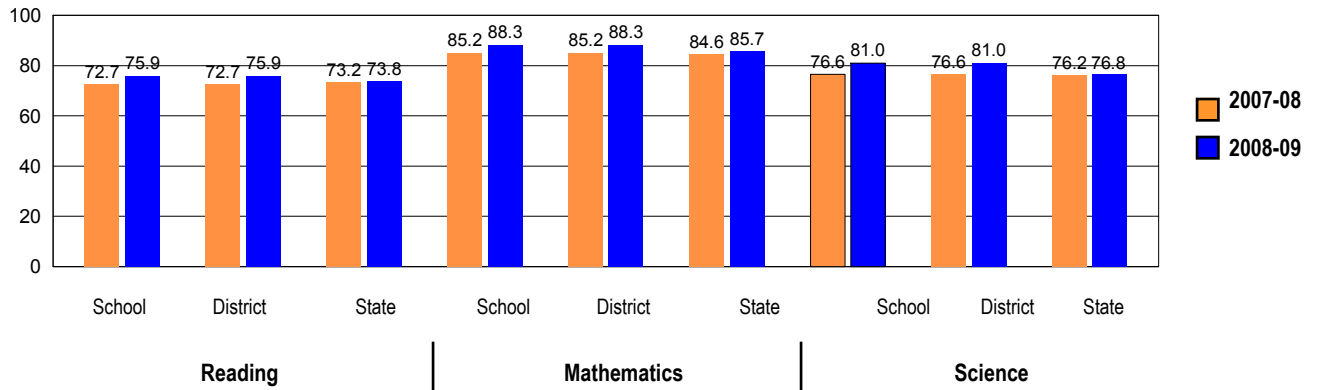


IAA scores in the Progressing and Attaining performance levels count the same, respectfully, as scores on other state assessments that meet or exceed Standards.

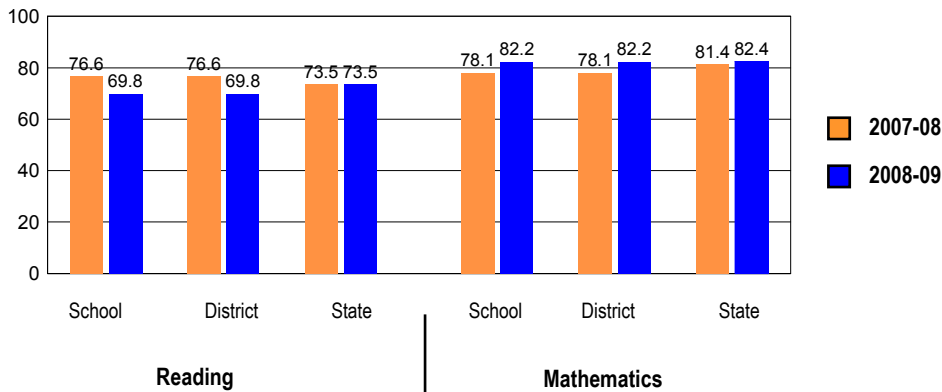

These charts provide information on attainment of the Illinois Learning Standards. They show the percents of student scores meeting or exceeding Standards for the grades and subjects tested on ISAT.

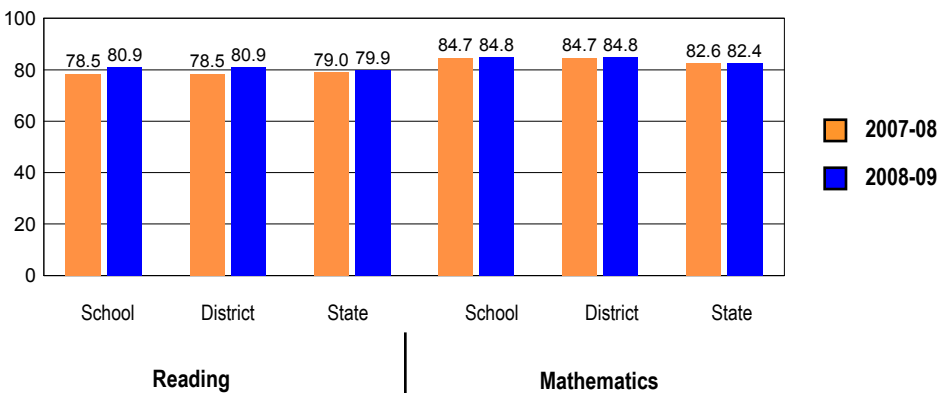
ISAT Grade 4

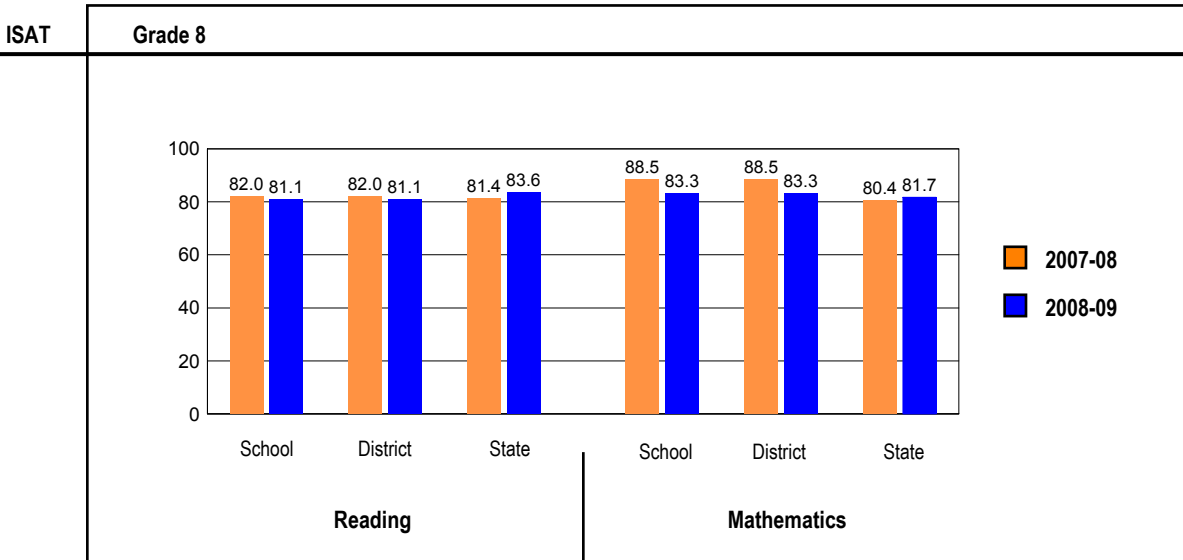
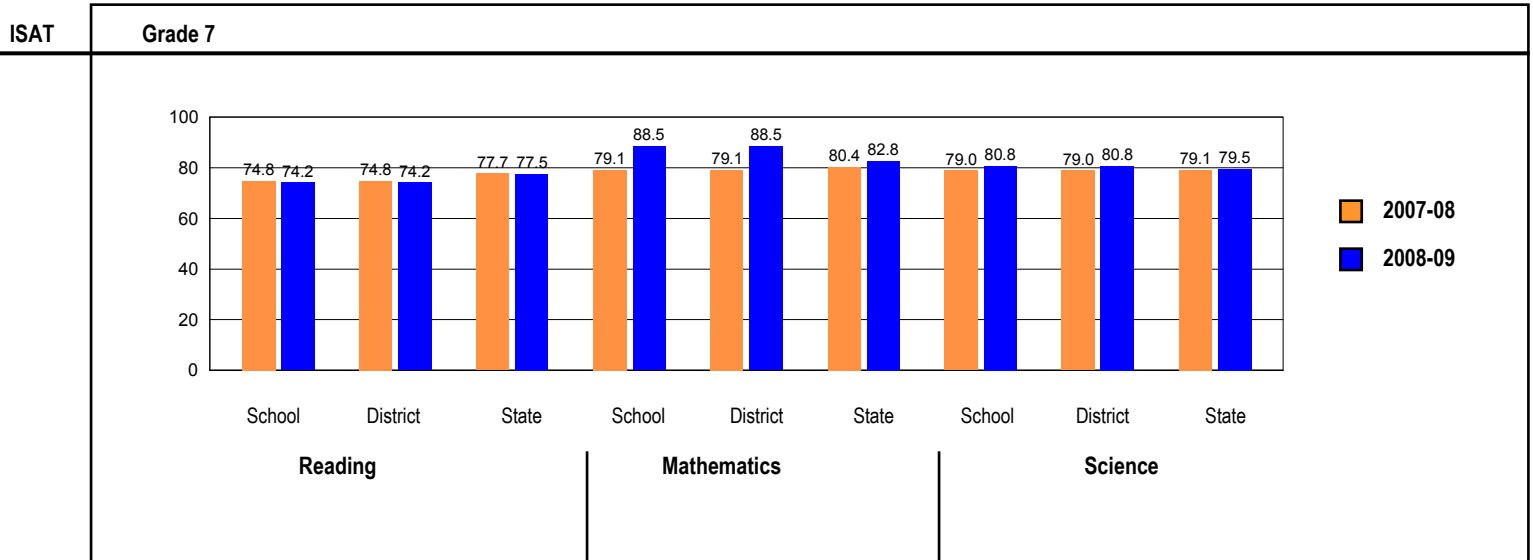


ISAT Grade 5

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

PLANNED IMPROVEMENT FOR THE SCHOOL AND DISTRICT

Based on the data from the School Improvement process, Northbrook School's areas of successes are:

- The 2009 Adequate Yearly Progress Status Report from the State Board of Education indicates that Northbrook School made Annual Yearly Progress (AYP) overall in the areas of reading and mathematics. All subgroups within the school are performing at state AYP minimum target levels. Northbrook has now made AYP in 2007, 2008 and 2009. This is a great area of success for our staff and students.
- Northbrook has continued to show academic growth overall in reading and math. For all students, the school has shown 15% growth in reading achievement from 2004 (63.4% M&E) to 2009 (77.4% M&E). In the area of Students with Disabilities, ISAT scores have risen from 2004 (11.9% M&E) to 2009 (45.9% M&E) in reading. Our Hispanic subgroup has shown a 19% growth in reading during the last five years from 2004 (50% M&E) to 2009 (69.4% M&E). Economically Disadvantaged students' reading scores have risen 23.5% from 2004 (48.1% M&E) to 2009 (71.6% M&E).
- Parent involvement continues to increase with a new computerized student management program and development of a new district website.

Based on the data from the School Improvement process, Northbrook School's area of planned improvement include:

- Based on 2009 student report card data, all subgroups within the school are performing at state AYP minimum target levels. Based upon past report card data and the 2009 ISAT data, subgroups to target for improvement include Hispanic, Students with Disabilities, and Economically Disadvantaged in the area of reading.
- Response to Intervention (RTI) and AIMSWEB testing, per the RTI plan, have been implemented at Northbrook School. It is a School Improvement goal to continue to look at data and criterion-based measurement toward enhancing the RTI process. Northbrook Administration and RTI teams will continue to utilize research-based interventions to improve student progress in all three tiers.
- Northbrook School will begin to investigate new reading and writing series and textbook resources through goal setting and committee construction.
- Northbrook School will continue to monitor curriculum changes from 2008-2009, and utilize staff training sessions in Differentiated Instruction and Progress Monitoring during institute days led by district leaders and AIMS trainers.
