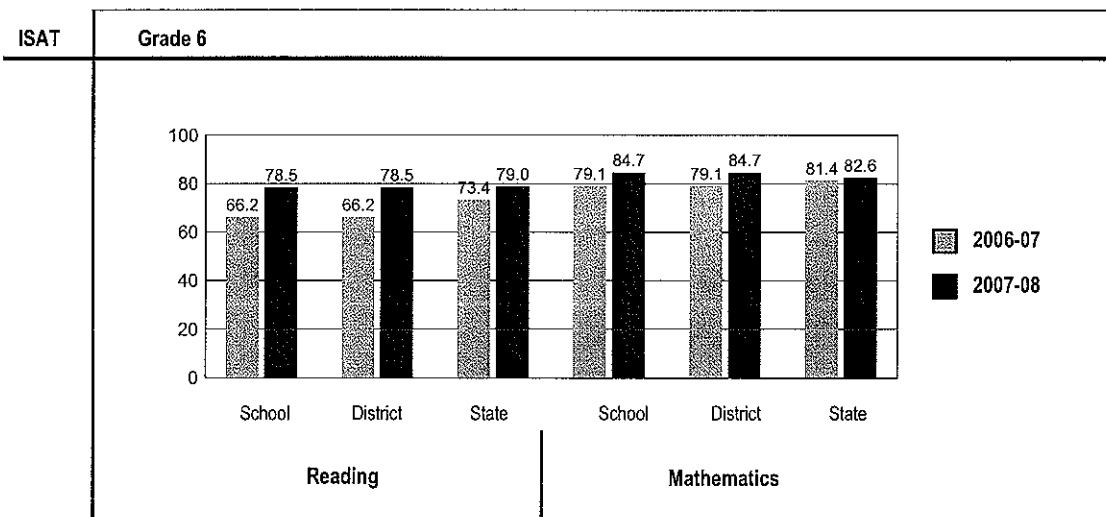
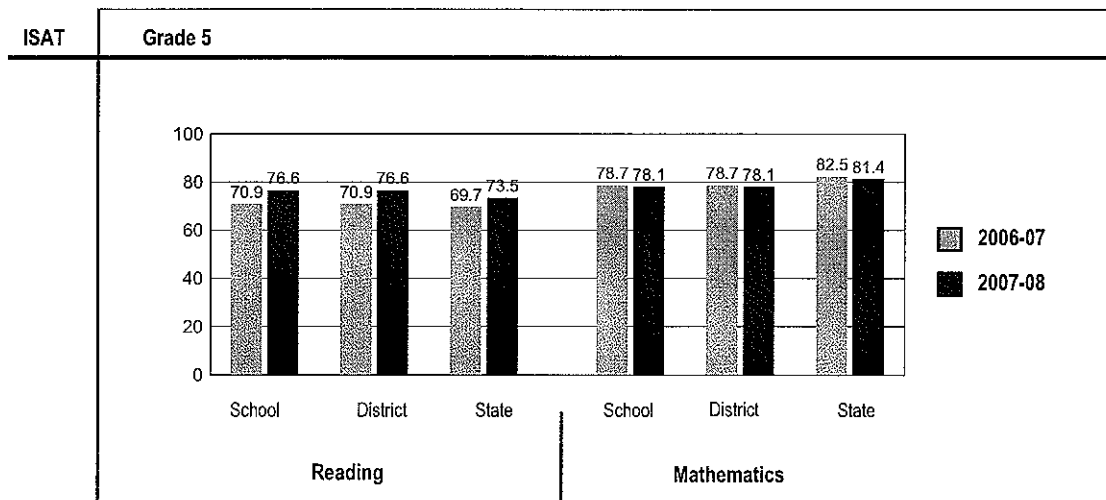
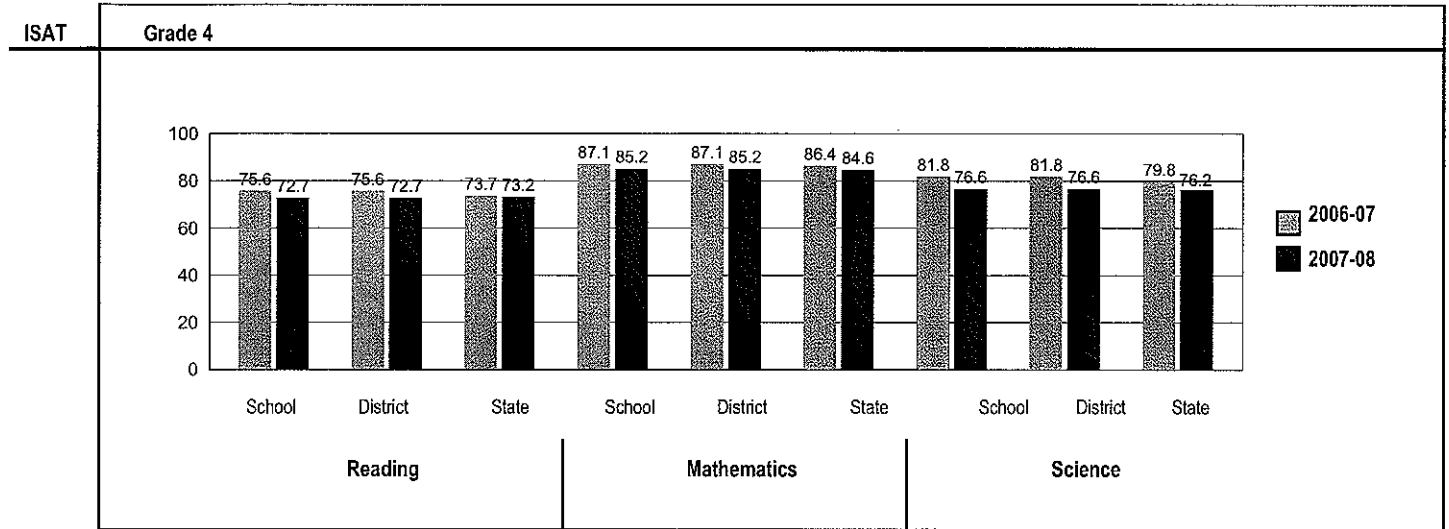


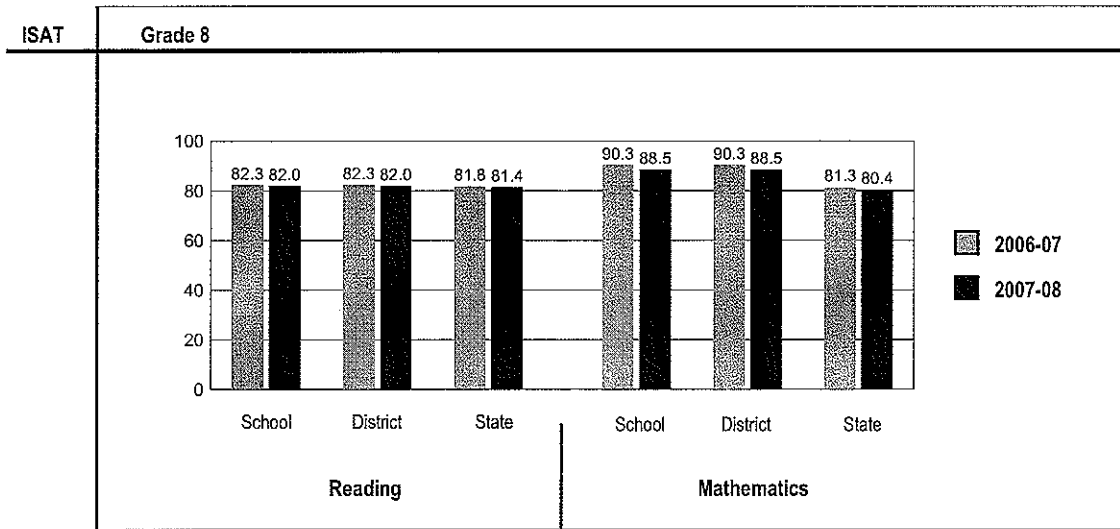
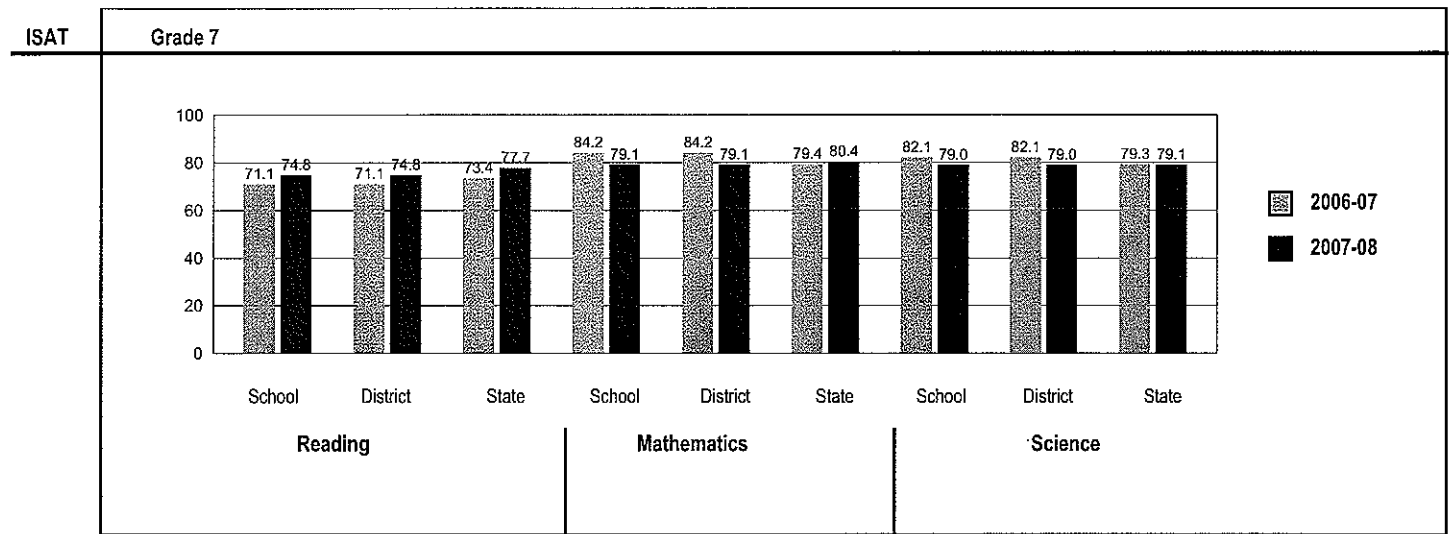


IAA scores in the Progressing and Attaining performance levels count the same, respectfully, as scores on other state assessments that meet or exceed Standards.

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

PLANNED IMPROVEMENT FOR THE SCHOOL AND DISTRICT

Based on the data from the School Improvement process, Northbrook School's areas of successes are:

- The 2008 Adequate Yearly Progress Status Report from the State Board of Education indicates that Northbrook School made Annual Yearly Progress (AYP) overall in the areas of reading and mathematics. All subgroups within the school are performing at state AYP minimum target levels. Having made AYP in 2007 & 2008, we are no longer identified as being in need of School Improvement. This is an area of great success for Northbrook School.
- Even as the percentage of students required to meet or exceed has risen for the past five years, Northbrook School has continued to show academic growth overall in reading and math. For All Students, the school has shown a 14% growth in reading achievement from 2003 (64% M&E) to 2008 (78.3% M&E). In the area of Students with Disabilities, ISAT scores have risen from 2003 (32% M&E) to 2008 (39.4% M&E) in reading. Our Hispanic subgroup has shown a 22.5% growth in reading during the last five years, from 2003 (46% M&E) to 2008 (68.5% M&E). Economically Disadvantaged students' reading scores have risen from 21% in 2003 (44% M&E) to 2008 (68.9% M&E).
- Results from the EXPLORE test the 8th grade participated in for the first time in the fall of 2007, Northbrook scored at or about the National norm in the areas of English, Math and Science.

Based on the data from the School Improvement process, Northbrook School's area of planned improvement include:

- Based on 2008 student report card data, all subgroups within the school are performing at state AYP minimum target levels. Based upon past report card data and 2008 ISAT data, subgroups to target for improvement include Hispanic, Students with Disabilities and Economically Disadvantaged in the area of reading. Additionally, the Students with Disabilities subgroup are also an area to address math needs.
- The focus of our school improvement plan for the year will be implementing Response to Intervention (RtI) and AIMSweb in the building. Northbrook's commitment to tiered instruction as a result of analyzing data and implementing scientifically research-based interventions is demonstrated through its professional development plan and calendar.
- Implementing a new K-6 math curriculum this year and investigating 7/8 curriculum for next year.
- Parent involvement will be increased with a new computerized student management program and development of a new district website. Parent informational meetings will be scheduled throughout the year.
